10-YEAR LIMITED WARRANTY CERTIFICATE

SAVE THIS CERTIFICATE. It gives you specific legal rights, and you may also have other rights that may vary from state to state. This Limited Warranty is issued by GRANBY STEEL TANKS. Fill in the installation date, model and serial numbers of the tank in the space provided below and retain this Limited Warranty for your files.

GENERAL TERMS

SUMMARY: Subject to the conditions and limitations stated here in, Granby Steel Tanks fuel oil tanks are warranted against defects material and workmanship for ten (10) years following date of installation.

This Limited Warranty applies to the original purchaser and subsequent transferees, but only while the tank remains at the site of the original installation and only if the tank is installed inside the continental United States and Alaska. The Limited Warranty applies only if the tank is installed by an installer whose competence is recognized by local authorities having jurisdiction installed and operated in accordance with instructions available on the web at www.granbytanks.com, and in compliance with all applicable installation and building codes and good trade practices. The Limited Warranty applies only if the tank is used to store heating oil and no other substances are introduced into the tank. As used in this Limited Warranty, "installation" means the original installation of the tank.

During the first ten (10) years after installation, we will provide a replacement tank of similar size and configuration if your tank becomes perforated as a result of defects in materials or workmanship. All replacement tanks will be warranted for the remaining portion of the warranty period on the original tank. The dealer or qualified service technician must return the defective tank to a distributor that sells Granby Steel Tanks, and exchange it for a replacement tank.

In lieu of providing a replacement tank, we may, at our sole option, refund to you an amount equal to the distributor's purchase price from us, or provide to you a credit equal to that amount to be applied toward the purchase of any new tank that Granby Steel Tanks manufactures.

Any labor, material, freight and/or handling charges associated with any repair or replacement pursuant to this Limited Warranty is not covered by this Limited Warranty and will be your responsibility.

In establishing the date of installation for any purpose, including determination of the starting date for the term of this Limited Warranty, proof of the original installation date must be presented (you must retain the original records that can establish the installation date of your tank), otherwise the effective date will be based upon the date of tank manufacture, plus thirty (30) days.

We will not be responsible for and you, the user, will pay for: (a) damages caused by accident, abuse, negligence, misuse, riot, fire, flood, or Acts of God (b) damages caused by operating the tank where corrosive elements have been introduced and allowed to reside inside the tank other than those found in a normal residential environment (c) damages caused by an unauthorized alteration or repair of the tank affecting its stability or performance (d) damages caused by improper matching or application of the tank or the tank's components (e) damages caused by failing to provide proper maintenance to the tank (f) any expenses incurred for erecting, disconnecting, or dismantling the tank (g) parts or supplies used in connection with service or maintenance (h) damages, repairs, not in operation or inefficiency resulting from faulty installation or application.

In no event shall we be liable for any incidental, consequential, or special damages or expenses in connection with any use or failure of this tank other than conditions included in this Limited Warranty Certificate. We make no other condition or warranty, express or implied, and specifically disclaim all statutory implied warranties or conditions, including merchantability and fitness for a purpose, to the greatest extent allowed by law. Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages or do not allow limitations on how long an implied warranty or condition lasts, so the above limitations or exclusions may not apply to you. The provisions of this Limited Warranty are in addition to and not a modification of or subtraction from any statutory warranties and other rights and remedies provided by law.

LIMITED WARRANTY TERMS

In the event a UL-142 tank is determined to have failed under warranty, Granby Industries L.P. will provide you with a replacement tank of similar size and configuration or, at our sole option, repair or refund to you an amount equal to the distributor's purchase price from us, or provide to you a credit equal to the amount to be applied toward the purchase of any new tank that we manufacture. To obtain a replacement tank, the dealer or qualified service technician must return the defective tank to a Granby Industries L.P. authorized distributor and exchange it for a replacement tank. All replacement tanks will be warranted for the remaining portion of the warranty period on the original tank.

Granby Industries L.P. will not allow for any reimbursement amounts for labor, material, freight and/or handling charges associated with the repair or the replacement of a tank.

This Limited Warranty applies to the original purchaser and subsequent transferees, but only while the tank remains at the site of the original installation and only if the tank is installed inside Canada and the continental United States of America.

LIMITED WARRANTY RESTRICTIONS

This Limited Warranty applies only if the tank is:

- Installed by an installer whose competency is recognized by local authorities having jurisdiction.
- Installed in accordance with instructions enclosed with your tank (also available at www.granbyindustries.com) **and** in accordance with the oil tank's rating plate instructions **and** in compliance with all applicable installation and building codes, best trade practices such as those described in the Canadian Oilheat Association (COHA) Today's Oilheat Technician's Manual, and those described in the National Oilheat Research Alliance (NORA)'s Heating Oil Storage Tanks, Guide for Quality Installation and Maintenance and/or other industry equivalents.
- Used only for the aboveground storage of flammable and combustible liquids compatible with the material of construction and with a specific gravity not greater than 1.0.
- Operated, serviced and maintained in accordance with instructions enclosed with your tank (also available at www.granbyindustries.com) at least once every twelve (12) months and in compliance with all applicable installation and building codes and best trade practices and/or other industry equivalents.

In establishing the installation date for any purpose, including determination of the starting date for the term of this Limited Warranty, proof of the original installation date must be presented (you must retain the original records that can establish the installation date of your tank), otherwise, the installation will be deemed to have occurred no more than 180 days after the date of tank manufacture.

This Limited Warranty does not create liability for Granby Industries L.P. for any incidental, consequential, or special damages or expenses in conjunction with any use of this tank. It also does not cover damages caused by: (a) accident, abuse, negligence, misuse, riot, fire, flood, or Acts of God (b) the operation the tank where corrosive elements have been introduced and allowed to reside inside the tank other than those found in a normal use environment (c) an unauthorized alteration or repair of the tank affecting its stability or performance (d) improper matching or application of the tank or the tank's components (e) falling to provide proper maintenance to the tank (f) erecting, disconnecting, or dismantling the tank (g) parts or supplies used in connection with service or maintenance (h) faulty and/or negligent installation, maintenance or application or (i) spills from overfills.

We make no other condition or warranty, express or implied, and specifically disclaim all statutory implied warranties or conditions, including merchantability and fitness for a purpose, to the greatest extent allowed by law in your state.
